Township Committee, constitutes as award to provide Electric Generation Service to Participating Residential Customers in the Township, subject to the terms of the MPA and RFP, including the opportunity for opt-out without penalty.

ConEdison Solutions has executed and submitted along with its bid the Transmittal Letter in which, among other things, it has agreed to execute the MPA with the Township. It is further confirmed that ConEdison Solutions has not taken any exceptions to the bid specifications or the MPA¹. This Award Letter is based upon such commitments and confirmations.
