**PUBLIC NOTICE**  
**REGARDING MONTGOMERY TOWNSHIP**  
**2010-2011 MUNICIPAL DEER MANAGEMENT PROGRAM**

**PLEASE TAKE NOTICE** that pursuant to the Montgomery Township Deer Management Program, the Township will again allow limited deer hunting this fall and winter on certain publicly-owned open spaces located in the Township.

**PLEASE TAKE FURTHER NOTICE** that **beginning September 11, 2010 and ending February 19, 2011 the following areas will be hunted** by municipal permit only:

- (1) **Folusiak** on Hollow Road, just north of the railroad tracks
- (2) **Opatut and adjacent land** on Route 518 and Pine Brae Drive
- (3) **Dead Tree Run** on Dead Tree Run Road (bow only)
- (4) **Ingersoll-Rand** on Montgomery Road (bow only)
- (5) **Runyon Farm-Fox Brook-Tomenchok** on Route 206 and Sunset Road
- (6) **Dale/Washington Well** on Route 518 and Burnt Hill Road (bow only and no hunting on northern 15± acres near the sledding area after the first snowfall or November 15, whichever is earlier)
- (7) **Broadway Area** located on Broadway (bow only and no hunting from November 24 to November 28, 2010, inclusive)
- (8) **Somerset Holding/Bridgepoint Road** on Bridgepoint Road (bow only)
- (9) **Nicolaysen** on Cherry Valley Road (bow only)
- (10) **Zeloof** on Belle Mead-Blawenburg Road

In addition, the Township will offer ten supplemental restricted permits on the following four properties to certain prior Deer Management Program permittees in accordance with Township Committee Resolution # 10-4-104:

- (11) **Bennett** on Provinceline Road (bow only from designated tree stands, hunting strictly limited to northern 31± acres of lot 9.03, no ground hunting/stalking, and no hunting when snow on ground)
- (12) **Platz** on Dutchtown-Harlingen Road (bow only from designated tree stands, and no ground hunting/stalking)
- (13) **Montgomery Meadows** on Brandywine Road (bow only from designated tree stands, no ground hunting/stalking)
- (14) **Saxon Ridge** on the corner of Route 601 and Sunset Road and on Saxon Way (bow only from designated tree stands furnished by Township, no ground hunting/stalking, no hunting when snow on ground, and no hunting in areas south of brook that traverses the property)

Hunting is allowed by law to take place Monday through Saturday starting one half hour before sunrise until one half hour after sunset. No hunting is allowed on Sundays or on Christmas Day.

Warning signs will be posted along the boundaries and entrances of each of the properties. All State and local regulations pertaining to parks and to hunting remain in full force and effect and will be enforced by the Police Department of the Township of Montgomery.

The individuals who have been issued hunting permits for these properties will have taken detailed safety courses and are familiar with the properties they will be hunting. The public should nevertheless take all necessary precautions and exercise particular caution if present in the areas designated for hunting during authorized hunting periods.
