8. **RESOLUTION #16-6-130 - RESOLUTION AMENDING PROFESSIONAL SERVICES AGREEMENT** - Engineering Services - Menlo Engineering - Viburnum Drive, Spiked Rush Court, Sassafras Court Improvement Project

WHEREAS, By Resolution No. 15-8-207 adopted on August 6, 2015, the Township Committee awarded an agreement for professional services to the firm of Menlo Engineering Associates, Inc. ("Menlo") for the provision of engineering, permit administration, surveying and geotechnical services in connection with the Viburnum Drive, Spiked Rush Court, Sassafras Court Improvement Project, including roadway and drainage improvements ("Project"), for the sum of \$27,200.00 ("Agreement for Professional Services" or "agreement"); and

WHEREAS, The Township Engineering Department has requested that the Township Committee authorize Menlo to complete additional engineering services in connection with this Project, and in particular, to extend the scope of Menlo's services to include attendance at a public information meeting and engineering services in connection with the removal of pavement on Sedge Drive, which were not included in the original scope of services for said Project; and

WHEREAS, Menlo submitted a written proposal dated May 12, 2016 to complete these additional services for the sum of \$5,000.00 ("Proposal"), which Proposal shall be incorporated herein by reference; and

WHEREAS, The work set forth in the Proposal extends beyond the original scope of services with Menlo and therefore, the parties seek to memorialize the Proposal's scope of work and estimated cost by amending the existing agreement; and

WHEREAS, The existing agreement with Menlo was awarded without competitive bidding as a professional services agreement pursuant to N.J.S.A. 40A:11-5(1)(a)(i) and as a such, the Township Committee may amend same by resolution adopted under N.J.A.C. 5:30-11.6(e); and

WHEREAS, The Chief Financial Officer has certified that sufficient funds are available for this purpose.

NOW, THEREFORE, BE IT RESOLVED By the Township Committee of the Township of Montgomery as follows:

1. The existing Agreement for Professional Services entered into between the Township and Menlo Engineering Associates, Inc. ("Menlo") is hereby amended to extend the scope of Menlo's services to include attendance at a public information meeting and engineering services in connection with the removal of pavement on Sedge Drive, which were not included in the original scope of services for this Project, as detailed in Menlo's May 12, 2016 proposal, incorporated herein by reference, resulting in an increase in the contract amount by \$5,000.00, bringing the contract total, as amended, to \$32,200.00.
2. The Mayor and Clerk are hereby authorized and directed to execute an Amendment to Professional Services Agreement which shall be executed by the parties to confirm the additional scope of services and anticipated cost; the form of the Amendment to Agreement for Professional Services shall be subject to the approval of the Township Attorney.

9. **RESOLUTION #16-6-131 - AUTHORIZING A CONTRACT WITH THE COUNTY OF SOMERSET TO PROVIDE PARTICIPATION IN A COOPERATIVE MEANS OF CONDUCTING CERTAIN COMMUNITY DEVELOPMENT BLOCK GRANT AND HOME INVESTMENT PARTNERSHIP PROGRAM ACTIVITIES**

WHEREAS, Title I of the Housing and Community Development Act of 1974 provides for substantial federal funds being made available to certain urban counties for use therein; and

WHEREAS, The Community Development Block Grant Program and the HOME Investment Partnership Programs have benefited the County as a whole and has provided a unique opportunity for intermunicipal cooperation; and

WHEREAS, The program has provided substantial benefits to persons of low and moderate income including the elderly and disabled, and that these benefits would be lost without a renewal of the County cooperation agreement; and

WHEREAS, Montgomery Township desires to preserve benefits of the Community Development Block Grant Program and the HOME Investment Partnership Program for the County by renewing its participation in the Somerset County Community Development Consortium; and

WHEREAS, The Shared Services and Consolidation Act (NJSA 40A:65-1) provides a mechanism through which counties and municipalities may enter into agreements for the provision of joint services; and

WHEREAS, (NJSA 40A:65-1) provides that authorization for participation in such a cooperative program must be by resolution.

NOW, THEREFORE, BE IT RESOLVED, By the Township Committee of the Township of Montgomery, County of Somerset, New Jersey, that:

1. It does hereby authorize continued participation in the Somerset County Community Development Consortium or Urban County.
2. It does hereby authorize, ratify and confirm a certain agreement (hereinafter referred to as "Contract") between the Township of Montgomery and Somerset County entitled "Agreement Between the County of Somerset and Certain Municipalities Located Therein For the Establishment of Cooperative Means of Conducting Certain Community Development Activities" and is further authorized to amend language that is contained in the existing agreement to comply with new requirements from the Department of Housing and Urban Development. This agreement shall automatically renew in every successive qualification period unless notice that it wishes to withdraw is provided to HUD and Somerset County.
3. It hereby authorizes full participation by the Township of Montgomery in all aspects of the activities provided for within said Contract pursuant to the terms and conditions as more fully set forth in said Contract.
4. It hereby incorporates said Agreement into this Resolution by reference, as if fully set forth herein.
5. The Mayor and Municipal Clerk are hereby authorized to execute the Contract with the County and copy of said Contract will remain filed in the Office of the Municipal Clerk for public inspection.
