

PROJECT DESCRIPTION

The Township of Montgomery is accepting bids for the Stage II Wastewater Treatment Plant Headworks Upgrade Project. This project includes raising the perimeter walls of the Headworks structure, installation of a new stairway, handrails and access platforms, installation of a new vertical screen, screenings washer/compactor and wet well mixer, relocation of an existing channel grinder, replacement of existing grit removal and air diffusion equipment, removal of an existing manual bar screen, and other miscellaneous piping, mechanical, instrumentation and electrical work, and all appurtenant work required by the Contract Documents.

Specifications and other bid information may be reviewed and obtained at the Engineering Department during regular business hours 8:00 am to 4:30 pm. Any notices of addendums or cancellation and postponements may be found at www.Montgomery.nj.us under current bidding opportunities. Bid documents are provided free of charge on a CD-ROM or emailed in Adobe PDF format. A free version of Adobe Reader can be downloaded at www.adobe.com. Should an email copy be requested, an email address shall be provided that permits delivery certification and the requester shall confirm receipt of the bid documents in writing. Should a paper copy be requested, a **NON-REFUNDABLE fee of \$200.00** in the form of a check payable to the "Township of Montgomery" is required for each set of bid documents. Bid packages will be over-nighted on a CD-ROM in Adobe PDF format upon the receipt of the bidders UPS account number.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27-1 et seq.

Please take further notice that on or about January 11, 2018, the Township caused the publication of an advertisement for the receipt of bids for these services to take place on February 15, 2018. Pursuant to the Local Public Contracts Law, the February 15, 2018 receipt date has been postponed to February 22, 2018. However, the bidding and contract documents issued by the Township for the original February 15, 2018 bid receipt, along with the document subsequently annexed thereto and entitled "Addendum No. 1" are to be used for the February 22, 2018 opening. Any new bidders shall be provided the same bidding and contract documents, along with Addendum No. 1.
